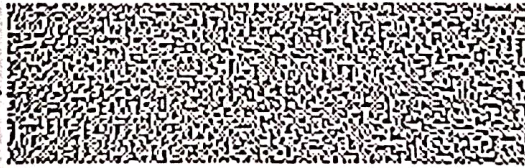

WHEREAS, the Medical Establishments like Hospitals, Clinics, Nursing Homes and related establishments which generally generate Bio-Medical waste, are now governed by the provisions of Environment (Protection) Act, 1986 read with Bio-Medical Waste (Management and Handling Rules) 2016, whereas with an intention to comply the above mentioned provision strictly had in as above mentioned Service Provider are authorized by the Karnataka State Pollution Control Board.

TERMS AND CONDITION:

1. That Jain AGM Ayurvedic Medical Hospital Varur, Hubli will extend its full co-operation and support to the Service Provider with regards to Bio Medical Waste Management.
2. The service provider shall treat and dispose of Bio-Medical Waste in accordance with the schedules and in accordance with prescribed in schedule to the Bio-Medical Waste Rules 2016.
3. That it is mutually agreed upon by M/s Rio Green Environ India ASTS to collect and dispose all type of segregated Bio Medical Waste generated at Jain AGM Ayurvedic Medical Hospital Varur Hubli at a monthly lump sum fees of Rs.5,000/- per month (Rupees Five Thousand per month).
4. That payment will be made once in a month by Jain AGM Ayurvedic Medical Hospital to Rio Green Environ India ASTS.
5. That both the parties i.e. Rio Green Environ India ASTS and Jain AGM Ayurvedic Medical Hospital shall arrange to obtain necessary valid authorization from prescribed authority i.e. Karnataka State Pollution Control Board from time to time.
6. That Rio Green Environ India ASTS confirms that the method of Categorization, Collection, Transport, Treatment and Safe Disposal of Bio Medical Waste in line with provision of the Environment protection Act rule made there under.
7. That Rio Green Environ India ASTS is responsible for daily collection of Bio-Medical Waste generated from Jain AGM Ayurvedic Medical Hospital without fail at a single declared place within Hospital Premises.
8. That Rio Green Environ India ASTS and Jain AGM Ayurvedic Medical Hospital will maintain the records of handling BMW and make monthly statement available to concerned institution of periodical review, so as to produce the same to the K.S.P.C.B authorities.
9. That it is the duty of Jain AGM Ayurvedic Medical Hospital Varur to collect segregated Bio Medical Waste generated from the Hospital and store in a color and bar coded bags as per Bio Medical Waste Rules Single Point within Hospital premises without fail.


10. That Rio Green Environ India ASTS shall ensure to take all precautionary steps to avoid leakage/spillage of BMW from the site of collection during transportation to storage area shall be properly protected/dis-infected and fenced.
11. That the original agreement is retained by Jain AGM Ayurvedic Medical Hospital and the copy of the same is retained with Rio Green Enviro India ASTS.
12. That it is mutually agreed that the contract will be valid for the period of TWO Years i.e from 01.04.2022 to 31.03.2024.
13. That all dispute to this understanding is subjected to the jurisdiction of the court in Dharwad District.
